
1. The college will actively participate in the programs organized by RRC. It will make other schools, NGO's and colleges to participate in the programs.

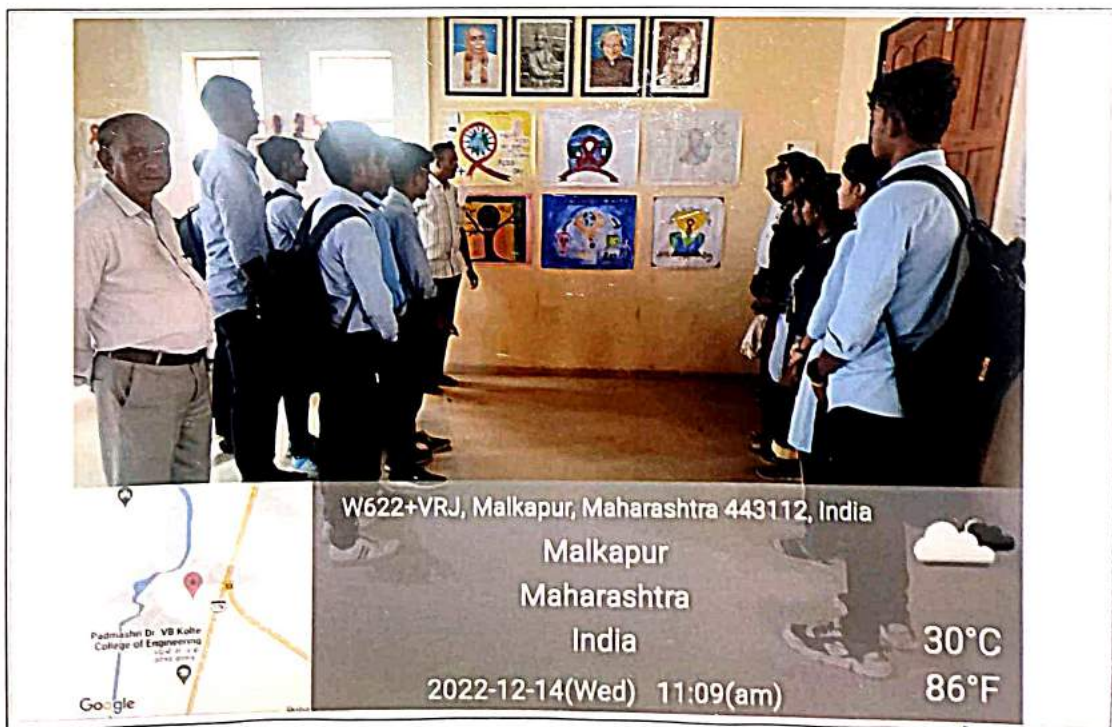

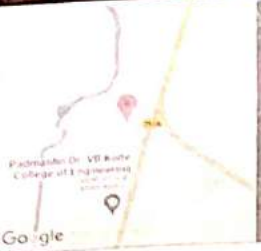
